Our Board of Education met last night for the purposes of reviewing a number of important topics. Here is a synopsis of their important work:

**COVID-19:** The pandemic continues to be front and center on the minds of many. Each of our 11+ District work groups are developing recommendations to mitigate safety concerns when school resumes on September 1. I am grateful to the parents, students, staff, and medical professionals who are sharing their time and talents with us. You are making the “heavy lift” a little lighter.

One important result, among many, from our June community-wide survey, centered on the importance of professionally developing our staff so they may be of even better service to our families and students. We have secured a number of highly regarded trainers in the field of online/blended teaching, and we are beginning our first of many training opportunities during the first week of August. In addition, we have heard from families who want to learn how they can better assist their children in a virtual platform. Videos are now being created and will be released in the weeks ahead.

We, too, are watching with great interest the number of confirmed cases in Dane County and Mount Horeb. We have a strong, positive working relationship with Public Health Madison and Dane County officials. Our district leaders are in daily communication with them and other school leaders from around the region. This has resulted in collaboratively developing protocols related to illness reporting, cleaning, and exposure mitigation. Any alteration in the Board of Education’s plan for the start the school year will reflect the data coming from PHMDC.

**Long Range Facility Plans Update:** The Board reviewed [these pictures](#) from projects that have been underway this summer. One only needs to drive past the Middle School to see the continued work on the main entryway’s metal roof and the re-designed front and back drop off/pick up areas. The Intermediate Center is also receiving a new roof, as the current is original. We were beginning to see the membrane portion of the roof failing at several points throughout the building. In addition, site work has continued in several of the parking lot areas.

End of School Year Goal Review: Each of our building principals were on hand in order to share with the Board an update as to the status of their buildings' goals. As several goals involved the Measure of Academic Progress and various standardized testing results (which were not administered due to the pandemic) the degree to which the goals we met could not be fully discerned. In action items, the Board of Education approved:

1. on second reading [policies](#) related to "Ceremonies and Observances" (323); "Religion in the Classrooms and Schools" (383) forwarded by the Education Committee (June 1); and "Local Student Scholarships and Awards" (460) referred by the Safety and Wellness Committee (June 15);
2. the annual declaration and parent notice of the District's [student academic standards](#) for the 2020–21 school year;
3. our annual [Education for Employment Plan](#); and
4. agreed with the administration's recommendation to approve Madison College's dual credit "[Mathematical Reasoning](#)" course for the 2021-22 school year.

Transportation remains a major driver in our fall planning. Public Health Madison and Dane County's revised *guidelines* no longer suggest a maximum number of passengers; however, will need to explore some unorthodox options.

- o We may need to seek a moratorium for in-town riders (2 miles or less) who do not traverse hazardous pathways to/from school. This would free up much needed busing capacity. We have a committee exploring all options at this point.
